ABC FUNDING: MORE REDUCTIONS AHEAD

BEFORE I COMMENCED WRITING THIS ARTICLE ON ABC FUNDING, I HAD JUST FINISHED WATCHING AN EPISODE OF ABC'S "BACKROADS" FEATURING THE TOWNSHIP AND COMMUNITY OF OMEO IN THE MOUNTAINS OF VICTORIA. LIKE ALL EPISODES OF "BACKROADS", IT FEATURED BRILLIANT PHOTOGRAPHY, EDITING AND STORYTELLING.

The programme gives viewers an insight into rural communities, their history, and sometimes features the eccentric individuals who live within the community. Most of all, the show highlights the sense of community that thrives within-country towns, individuals working together for the better good.

Only ABC is prepared to produce a programme like Backroads. Commercial media shy away from making such a programme. They would assume the programme will be uncommercial and would not attract viewers. Often, they are proven wrong, as the success of the Backroads series shows. I could go on list other ABC productions, unique in concept going onto become very popular over the decades.

Of course, there is more to the ABC than popular productions like Backroads; the ABC has been there for generations to support Australians in emergencies such as the recent bushfires. The ABC has also brought to the attention of Australians the corruption in the Banking Financial Services Industry and abuse in age care; just two examples in recent years. Australians know the ABC delivers unbiased news. The loss of seventy staff in the ABC News Division will further undermine our democratic process.

Unfortunately, ABC's ability to produce innovative programming and deliver essential services will decline as a result of inadequate funding. Our newsletter has reported on ABC funding problems over recent years. First, we had the Abbott government funding reduction of \$200m in the 2014 budget and the later requirement for efficiency dividends over successive years. Now there is a further \$84m reduction to take place over the next three years. The efficiency dividends have been in the range of two to three per cent per year and have had an adverse impact as they accumulate.

The federal government's perception that ABC and other public services can continue to do more with less is not only had an adverse on the ABC; we see the same in education, health and age care; just a few examples. Usually, the continued funding decline ends with a crisis. The government need to pour millions of dollars just to correct an immediate problem. Avoided if there had been adequate funding in the first place.

How much will the cuts hurt? As Media Watch reported on June 29

- Only 42 episodes a year of programmes like *Four Corners* and *Media Watch*, instead of up to 45.
- *Australian Story*, already down to 35 episodes a year, will be forced to run up to four repeats.
- *Foreign Correspondent* will be cut again, now down to 22 episodes. In 2016 it was 30 episodes.
- Already struggling on reduced budgets, the above two programmes will also lose money and travel less.
- ABC News will shed 74 jobs, while Entertainment & Specialist — responsible for drama, children's programmes, and shows like *Gruen*, *The Weekly* and *Mad as Hell* will lose a further 53 jobs
- The successful website ABC Life, a regular target for ABC critics, is another casualty, dumped and re-branded as ABC Local, with the loss of nine journalists who helped bring a new younger audience to the ABC.
- Fran RN Breakfast will also suffer, losing two senior reporters.
- ABC's top-rating radio news bulletin at 7:45am is to be axed, to the dismay and anger of its many fans.
- Meanwhile, ABC spending with independent producers will be cut by \$5 million a year, or around 5 per cent, most of it lost from factual programming, which produces popular shows like *War on Waste*, *Love on the Spectrum* and *Old People's Home For 4 Year Olds*.
- Less original TV on our screens and no new shows after 9.30pm.



AGED CARE IN AUSTRALIA

IN THE PAST THREE YEARS, THERE HAS BEEN INCREASING CONCERN OVER THE QUALITY OF AGE CARE IN AUSTRALIA. PERHAPS MORE THAN THREE YEARS, REMEMBERING THE KEROSENE BATHS. BACK IN 2017, SOUTH AUSTRALIA'S OAKDEN AGE CARE FACILITY WAS CLOSED FOLLOWING EVIDENCE OF RESIDENT ABUSE AND NEGLECT.

Just before the ABC's, Four Corners was to air a two-part investigation of the treatment of elderly Australians in aged care residents; Prime Minister Morrison announced a royal commission into the aged care sector. Mr Morrison was not going to have another electoral backlash like over his long-term opposition to establishing a royal commission into the banking and finance sector; after all, he was facing an election in six months.

Forward just over twelve months after its establishment, the aged care royal commission released its interim report, branding the system as "cruel and harmful". The report called for an urgent overhaul, finding services fragmented, unsupported and often unsafe. In response, the government promised more funding would flow before Christmas 2019. The federal opposition argued the new financing was only restoring some of the funding previously cut by the government. The budget documents show clear evidence of this.

Much more funding will be needed to reduce the numbers waiting for either placement in aged care residence or assistance for the elderly to remain in their home. The private sector is increasingly moving into the ownership and management of aged care residences.

The private sector is peeling out a profit in aged care; this is increasing the cost of aged care and causing the standard of care to sub-standard levels. The private sector, despite strong evidence to the contrary, continues to oppose minimum standards for residents to staff ratios and the mandatory availability of qualified nurses. Today, aged care staff are underpaid, over-worked and lack essential training; many carers work at two or more jobs because of the high proportion of their work is casual and part-time.

Indicative of the treatment of carers in aged care residents, Unions applied before the Fair Work Commission (FWC) for carers to receive leave if they needed to isolate themselves because of COVID-19.

While doing some research for the aged care article in this month's newsletter, I came across a Combined Pensioner and Superannuants Association (CPSA) article about the Federal Government Health Department's myagedcare website.

The article reports that myagedcare (myagedcare.gov.au) website will include a Service Compliance Rating system for Australian nursing homes; for those searching for an aged care provider on their website.

While we all hope for aged care to improve, the rating system for Australian nursing homes should disturb us.

The CPSA article makes a comparison between the Michelin Red Guide for restaurants and the Service Compliance Rating system for Australian nursing homes. The Service Compliance Rating system uses dots, four of them. The bold type is an interpretation.

One dot - the nursing home is under one or more sanctions and that the care is inadequate. **In other words, avoid!**

Two dots - the nursing home is operating under a notice of compliance. A misnomer, because, it is a notice of non-compliance: significant improvements are needed. **Again avoid!**

Three dots - the home has some areas where it should improve. **Avoid!**

Four dots - there are no known areas for improvement. **Enter if you must.**

Now compare this with Michelin Guide with its three-star ratings.

One star: a very good restaurant in its category.

Two stars: excellent cooking, worth a detour.

Three stars: exceptional cuisine, worth a special journey.

The CPSA article makes the correct point that unlike the Michelin Red Guide, the Service Compliance Rating system does not offer a rating of excellence. Instead, it rates how dreadful is a nursing home. **Missing are at least two more dots, one for good and the other for excellent.**



ABC FUNDING: MORE REDUCTIONS AHEAD (CONT'D)

The Communications Minister, Paul Fletcher suggests there has been no reduction to ABC funding. He points to the budget's small dollar amount increases to occur over the next three years. The minister conveniently ignores the issue of real financing, that factors in inflation. ABC Friends makes the valid analogy of employer who increases employee wages by \$10 a year and has the temerity to suggest they have all received a wage increase, so what is the problem.

ABC Friends quotes figures from Sydney and RMIT Universities that reveal a \$783 million shortfall in ABC funding 2014-2022. Other research by Per Capita confirms the Universities' research. The reality of the funding reductions comes with ABC Managing Director David Anderson confirming the ABC will absorb cumulative budget cuts that amount to \$105.9 million per annum by the time we reach the 2022 financial year. Up to 250 ABC staff now face the sack including 70 staff in the News division.

The ABC staff now face a challenging future. The COVID-19 crisis has hit hard the Arts and Entertainment industry having a devastating impact on people within the industry. Many of whom do not qualify for Job Seeker payments.

The May General Meeting discussed the ABC funding. There was a consensus that the *Retired Members Association* should assist ABC Friends in their resistance to the funding cuts to the ABC. In a few days, we will send an email to members asking them to write to the Prime Minister's Office stating their opposition to the funding reductions. There will be a link in the email to assist members.

AGED CARE IN AUSTRALIA (CONT'D)

The FWC granted the application, on the Union's second attempt, showing just how often the FWC will side with employers. Aged care operators opposed the Union's pandemic leave claim.

The aged care royal commission has made recommendations to improve age care in Australia. Let us hope their final report will make recommendations that will deliver a high quality of care and quantify staff levels and training and what this desired level of care will cost the Australian community.

Sadly, ahead of the royal commission's final report, the current COVID-19 pandemic is telling us just how inadequate age care is, particularly in the private age care residences. The resurgence of COVID-19 in Victoria is having a devastating impact on elderly Australians. In Victoria age care residences have the highest number of COVID-19 clusters; fifteen in total and with four residences having over a hundred infections. Victorian Premier Daniel Andrews has stated that he has no confidence in the private sector's management of age care residences during the current crisis. The federal government has had to send defence personnel and other nursing staff into many residences to manage the emergency.

Outside of the residences, anxious relatives are receiving little in the way communications about their aged relative health. Newmarch House in Sydney should have served as a warning of how inadequate the preparedness in the private sector was. At Newmarch, there were over seventy infections, and nineteen residents lost their lives. Yet only sixteen per cent received hospitalisation.
